ORDINANCE NO. 2026-02

AN ORDINANCE OF THE TOWN OF POMONA PARK, FLORIDA, LEVYING AD VALOREM TAXES FOR FISCAL YEAR 2026-2027; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Pomona Park, Florida, adopted a tentative millage rate for Fiscal Year 2026-2027 on September 9, 2026, following a public hearing held in accordance with section 200.065, Florida Statutes; and

WHEREAS, on September 23, 2026, the Town Council held a final public hearing, as required by section 200.065, Florida Statutes, to adopt the final levy of ad valorem taxes for Fiscal Year 2026-2027; and

WHEREAS, the Putnam County Property Appraiser has certified the gross taxable value for operating purposes within the Town, excluding exempt property, as \$50,847,377.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF POMONA PARK, FLORIDA, AS FOLLOWS:

Section 1. Purpose

1. The operating millage rate for Fiscal Year 2026-2027 is 6.9357 mills, which is 10.00% greater than the rolled-back rate of 6.3052 mills.
2. The voted debt-service millage rate is zero mills.

Section 2. Severability

Each phrase, sentence, paragraph, section, or other provision of this Ordinance is severable from all other phrases, sentences, paragraphs, sections, and provisions. If any phrase, sentence, paragraph, section, or provision of this Ordinance is declared unconstitutional or invalid by a court of competent jurisdiction, that declaration shall not affect any other portion or provision of this Ordinance.

Section 3. Conflicts

All ordinances or resolutions, or parts thereof, in conflict with this Ordinance are hereby superseded or repealed to the extent of such conflict.

Section 4. Effective Date

This Ordinance shall take effect immediately upon final passage as provided by law.

AN ORDINANCE OF THE TOWN OF POMONA PARK, FLORIDA, ADOPTING THE FINAL BUDGET FOR FISCAL YEAR 2026-2027; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Pomona Park, Florida, held a public hearing on September 9, 2026, in accordance with section 200.065, Florida Statutes; and

WHEREAS, the Town Council held a final public hearing on September 23, 2026, as required by section 200.065, Florida Statutes; and

WHEREAS, the Town Council has established appropriations and estimated revenues for Fiscal Year 2026-2027 in the amount of \$1,991,048.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF POMONA PARK, FLORIDA, AS FOLLOWS:

Section 1. Adoption of Final Budget

The final budget for the Town of Pomona Park for Fiscal Year 2026-2027, in the total amount of \$1,991,048, is hereby adopted as set forth in the Budget Summary attached to and incorporated into this Ordinance as Exhibit A.
